<b>Fire and Explosion</b>	Expected to be non-combustible.
<b>Health</b>	Cefadroxil monohydrate is contraindicated in patients with known allergy to the cephalosporin group of antibiotics.

<b>OVERDOSAGE</b>	<p>A study of children under six years of age suggested that ingestion of less than 250 mg/ kg of cephalosporins is not associated with significant outcomes. No action is required other than general support and observation. For amounts greater than 250 mg/kg, induce gastric emptying.</p> <p>In five anuric patients, it was demonstrated that an average of 63% of a 1 g oral dose is extracted from the body during a 6–8 hour hemodialysis session.</p>
