## Lupin receives FDA approval for Generic KEPPRA® Oral Solution 100 mg / mL

**Mumbai, October 19, 2011:** Pharma major, Lupin Ltd., announced today that its subsidiary, Lupin Pharmaceuticals Inc. (LPI) has received final approval for its Levetiracetam Oral Solution, 100 mg/mL from the U.S. Food and Drug Administration (FDA) for the company's Abbreviated New Drug Application (ANDA) to market a generic version of UCB's KEPPRA® Oral Solution 100 mg/mL. Commercial shipment of the product shall commence shortly.

Lupin's Levetiracetam Oral Solution, 100 mg/mL is the AA-rated generic equivalent of UCB's KEPPRA® Oral Solution 100 mg/mL. Levetiracetam Oral Solution is used in the treatment of myoclonic seizures, partial onset seizures and primary generalized tonic-clonic seizures in adults and children with epilepsy. KEPPRA® Oral Solution 100 mg/mL had annual sales of approximately \$63 million for the twelve months ended June 2011 based on IMS Health sales data.
